



## **Switch to Direct Deposit & Paperless Statements... it's easy!**

Ultra Resources, Inc. is now offering direct deposit to all Revenue Interest Owners. This is a great opportunity to receive payments electronically. It is safe, secure and offers many advantages which include:

- No lost or stolen checks
- No unnecessary trips to the bank
- If traveling, your check will still be deposited

Please fill out the attached form and return it to Ultra Resources. Please note that it may take up to 30 days for your request to be processed. Once your direct deposit information is set up, you will be notified via phone or email. Until such time, you will continue to receive paper checks in the mail.

**If you elect the savings account option, we will need your bank to fax or email us the Name of the account; the routing number and account number.**

Once Direct Deposit payments have been set up, Ultra Resources will no longer mail you any payment detail. We have partnered with Oildex to provide an Owner Relations Online system where you may obtain your revenue payment check detail, free of charge, via a secure website 24/7. This Owner Relations service will enable you to view and print your check stub detail in the same format as the remittance advice you previously received in the mail.

**Please note that Direct Deposit payments will not necessarily result in earlier receipt of payment.** It is expected that your electronic payment will be deposited in your bank account on the same date that you would otherwise receive a physical check.

You can access your current and archived monthly check detail from the Ultra website, as follows:

- Log on to the PureWest website – [www.purewest.com](http://www.purewest.com)
- Select the Owner/Vendor Relations tab located at the top right side
- Select Owner Relations
- Enter your login and temporary password, which will be provided to you by Oildex. If you have any questions, please contact them at [ormssupport@oildex.com](mailto:ormssupport@oildex.com) . They will need your 4 or 5 digit owner number for verification purposes.
- Complete the new user setup, creating your own login and password, as well as the security question for future correspondence.
- Access your information by selecting the Payment Information link

You may view and print the check remittance, or you may elect to have the remittance emailed to you. This may be done by accessing the Request Email link.
